First Training of Public Information Officers (PIOs) under KP Right to Information Act, 2013



The KP Judicial Academy broke a new ground through organizing a 2-day training for Public Information Officers (PIOs) on 11.06.2014, on the request of the newly constituted Provincial Information Commission, Government of Khyber Pakhtunkhwa. The PIOs are designated under the KP Right to Information Act, 2013. The training aimed at sensitizing

the PIOs, to their responsibilities under the law. The participants of this course included officers from different provincial departments like Archives, CM Secretariat, Education and Law. The course focused on the practical aspects of access to information. The course will help build capacity of the PIOs in the effective implementation of the law, encouraging accountability and transparency in the long run.

First 2 Days Training for Judges & Lawyers of District Chitral

10.06.2014



The Law & Justice Commission of Pakistan, requested the Academy to organize joint training programme, through its Access to Justice Development Fund, for lawyers and judicial officers of different districts of the KP, falling within the jurisdiction of PHC Peshawar and its benches at Abbotabad, DI Khan, Swat, Chitral and Bannu. The first batch of

Judges and Lawyers from District Chitral received their training at the Academy on 09-10 June, 2014. As many as 37 lawyers and 2 judges (total 39) participated in this course. At the concluding ceremony, all successful trainees received their certificates from the Director General KPJA Mr. Hayat Ali Shah.

Second 2 Days Training for Judges & Lawyers of District Dera Ismail Khan

11-12 June, 2014



Through Access to Justice Development Fund trainings' series, the second training was organized for the judges and lawyers of DI Khan. As many as 47 lawyers and 07 judges (total 54) participated in the 2 days training program. They were conferred certificates in the concluding ceremony.

Third 2 days training for Judges & Lawyers of District Bannu

13-14 June, 2014



In the third of its series, training for lawyers and judges from Bannu, concluded on 14th of June. A total of 45 participant, including 14 judges and 21 lawyers, were trained on various subjects. The DG Academy awarded certificates to all the participants.

Second Training of Public Information Officers (PIOs) under K-P Right To Information Act, 2013

17-18 June, 2014



In line with its agenda of training all the actors of the justice sector, the Academy arranged the second 2-day training for Public Information Officers (PIOs). This training was conducted on the request of the newly constituted Provincial Information Commission, KP. The participants were trained, how to better perform their newly assigned duties under the KP

Right to Information Act, 2013. Some 35 officers were benefited from this training.

Fourth 2 days training for Judges & Lawyers of District Swat



16-17 June, 2014

The fourth batch of trainee judicial officers and lawyers from Swat passed out of the two day training programme, conducted through Access to Justice Development Fund (Law and Justice Commission of Pakistan). As many as 67 lawyers and 22 judges (total 98) participated in this programme.

Fifth 2 Days Training for Judges & Lawyers of District Abbotabad

18-19 June, 2014



The judicial officers and lawyers, working in Abbotabad received two days training in the Academy. The trainees included 28 judges and 56 lawyers. This was the fifth such training, conducted by the Academy through the Access to Justice Development Fund of the Law & Justice Commission of Pakistan. In a simple concluding ceremony, the DG

Academy Mr. Hayat Ali Shah conferred certificates on the trainees.

Third Training of Public Information Officers (PIOs) under KP Right to Information Act, 2013

Third session of 2-day training for Public Information Officers (PIOs) was organized at the KP Judicial Academy. The batch consisted of Medical Doctors designate Public Information Officers, who were drawn from different districts' hospitals.
