




#### 1.0 Introduction:

- 1.1. It is critical that all judicial professionals have a strong understanding of family laws for the family law system to be accessible, equitable, responsive, and prioritize the safety of affected families. From 10-12 November 2021 UN Women Pakistan and the Khyber Pakhtunkhwa Judicial Academy joined hands to organise a three-day professional development course for family court judges.
- 1.2. The three-day training course primarily focused on the following topics:
  - Marriage, Dower, and Divorce under established Muslim jurisprudence
  - Composition, Functions, and Jurisdiction of Family Courts
  - Specialized Procedures of Family Courts
- 1.3. The course was designed to emphasize the unique aspects of Muslim family institutions, with interactive sessions examining topics in Muslim family law critically.
- 1.4. The participants were taught how to examine Pakistani family law in light of Shariah and how to analyze leading family court decisions.

## 2.0 Objective:

The course was designed with an aim to provide an overview of the legal framework of Pakistan's Family Courts, including their composition, functions, jurisdiction, and specialized procedures, as well as restitution of conjugal rights, judicial recognition of marriage, domestic violence, maintenance of wife and children, and child custody.







## 3.0 Purpose of the report:


- 3.1 The report aims to document the details of the training held from 10-12 Nov 2021.






Justice(R) Nasira Javed Iqbal (one of the first five women appointed to the Lahore High Court; she served as a justice from 1994 to 2002)







## 8.0 Proceedings:

#### 8.1 Day 1

#### **Welcome Note**

Mr. Zia- Uddin- Khattak; the Director General of the Khyber Pakhtunkhwa Judicial Academy gave a welcome address in which he highlighted the Quranic teachings in detail on the importance of family institutions.

The Director General welcomed the participants and congratulated them on their selection for this course in his inaugural address. He also expressed gratitude to the resource persons for taking time out of their busy schedules to speak at the Academy.


He also gave a brief overview of family laws in the context of Shariah, the Islamic Republic of Pakistan's Constitution, and national laws. He emphasized the importance of the judge family court's office in the current era as to how the Family Court should make all-out efforts and strive hard to repair broken family ties through conciliation and mediation.

A family court judge's job is complicated and one-of-a-kind in the legal system. On the one hand, a judge is expected to uphold the court's rules, remain impartial, and to only intervene in resolving disputes that are necessary to keep the process moving forward and on the other hand is required to urge the litigating parties to assimilate the sanctity of marriage for salvation of the family unit.

Following the opening remarks, the forum was turned over to the resource persons to share their knowledge and experiences with the participants.

- Retired Justice Nasira Iqbal spoke about the legal framework of Pakistan's family courts in the first session of the day. The details of the Dissolution of Muslim Marriages Act of 1939, the Muslim Family Laws Ordinance of 1961, the West Pakistan Family Courts Act of 1964, and the Family Court Rules of 1965 were shared. Marriage, Dower, and Divorce under established Muslim jurisprudence were also discussed in the second half of the session.
- Syed Yasir Shabbir gave a presentation on the Composition, Functions, and Jurisdiction of Family Courts in the second session. The session covered the details of family courts' jurisdiction, general procedure, mode of service of summons/notice, and use of technology.
- Dr. Faqir Hussain gave the final session of the day one on Specialised Procedure of Family Courts. In a comprehensive manner, he explained Reconciliation Proceedings, Restoration of Haq Mehr by the wife when a decree for dissolution of marriage is issued, and principles under established Muslim jurisprudence and enunciated by superior courts.








#### 8.2 Day 02

- During the first session of day two, Justice Retired Nasira Iqbal discussed restitution of conjugal rights and jactitation of marriage in depth.
- Dr. Faqir Hussain delivered a lecture on Domestic Violence Offences /Schedule (Part-II) Sec. 5 FCA, 1964 and discussed the Scope with the participants.
- Ms. Farah Jamshed gave the final session of day two on maintenance. Various aspects of this topic were thoroughly explained, including wife's maintenance during marriage and after divorce. Procedural issues were also discussed.

### 8.3 Day 03

- Dr. Faqir Hussain presented a session on Child Custody. He discussed the principles of upbringing, education, and parental love for children who are caught in the middle of parental disagreements. Some of the Supreme Court of Pakistan's Guidelines on Custody, Visitation Rights, and Guardianship were also shared.
- Ms. Wadeeya Mushtaq facilitated a mock activity on Pre- and Post-Trial Reconciliation, Interim Custody Proceedings u/12 of the Guardian and Wards Act, 1890.
- Ms. Nusrat Yasmin presented the day's final session on Trial Procedure, which included information on evidence evaluation, judgement writing, and decree execution.








# 9.0 Impact of the training:

Significant indicators of the training impact are:


- 9.1 Whether the training contributed to an improvement in the knowledge of the participants?

The evaluation questionnaire was designed to deal with this aspect. The relevant feedback obtained from the participants is reflected below:













# **10.0** Quality of the training:
