EXECUTIVE SUMMARY

This report encapsulates the proceedings of two webinars conducted by the Khyber Pakhtunkhwa Judicial Academy (KPJA) on "Revised District Legal Empowerment Committees (Constitution & Functions) Rules and Its Significance." Held on November 22, 2024, these webinars targeted District & Sessions Judges, who serve as ex-officio chairpersons of the District Legal Empowerment Committees (DLECs), along with representatives of the Law & Justice Commission of Pakistan (LJCP).

The concept note of this initiative forms the introduction, outlining the objectives, rationale, and expected outcomes of the training. The objectives of the webinars were succinctly to familiarize participants with the latest amendments to the DLEC Rules, address operational challenges, and promote the efficient utilization of free legal aid services.

The report details the proceedings of the two sessions and provides annexure that include the schedule of activities and pictorial highlights of the online sessions. This initiative reflects KPJA's ongoing commitment to enhancing access to justice by equipping judicial officers with the necessary tools and knowledge to ensure equitable and efficient legal aid delivery.

INTRODUCTION

Legal aid is more than a service; it's a cornerstone of justice, ensuring that every individual, regardless of their financial standing, has access to fair representation and equality before the law. Recognized globally as a fundamental human right, legal aid is pivotal for guaranteeing fair trials, preventing discrimination, and upholding the principle of equality. The Constitution of Islamic Republic of Pakistan, 1973, enshrines the fundamental rights of citizen, reinforcing the nation's commitment to justice for all. Despite these robust legal frameworks, the practical implementation of legal aid remains fraught with challenges, particularly due to financial constraints. The Law & Justice Commission of Pakistan, in exercise of power conferred by subsection (1) of section 9 of the Law & Justice Commission of Pakistan Ordinance, 1979, laid down the District Legal Empowerment Committees (Constitution & Function) Rules, 2011. These rules govern the composition, establishment, and functions of District Legal Empowerment Committees, specifically providing legal aid to litigants with limited financial resources. Pursuant to its rule 2(b), the primary objective of these committees is to assist individuals unable to obtain legal aid or protection for their genuine rights and interests due to financial constraints. Furthermore, the rules outlines for granting legal aid and selecting suitable legal practitioners. Ensuring effective implementation of these legal aid instruments is crucial to bridging the gap between legal rights and accessible justice. Under rule 2(d) of the District Legal Empowerment Committees (Constitution & Functions) Rules, 2021, one of the primary sources of funding for the District Legal Empowerment Committee, inter-alia, is the Legal Empowerment Fund Window of Access to Justice Development Fund (AJDF). The Governing body, AJDF through latest amendments made in District Legal Empowerment Committees (Constitution & Functions) Rules, 2011, vide Notification No. 14/198/2005/LJC-AI, dated October 12, 2023 has increased the professional fee of legal practitioners to be appointed for free legal aid from Rs. 20000/- to Rs. 40000/- depending upon the nature of the cases.

The Commission has also revised the eligibility criteria for legal practitioners from 5 years to 3 years of standing at Bar and empowered the District Legal Empowerment Committee, in consultation with the President District Bar Association, to select the panel of Lawyers. Previously, this mandate was with the Vice Chairman of the Provincial Bar Council, subject to the approval of the Chief Justice of the respective High Court. Additionally, a new sub rule 8 (i-A) has been inserted, stipulating that the list of legal practitioners shall be notified for the period of 02 years. The performance of DLECs was reviewed by the Governing Body of Access to Justice Development Fund (AJDF) and it was observed that optimum benefit of this unique

forum is not being achieved due to lack of awareness amongst the masses and even the relevant stakeholders are unaware about the existence of such committees and their mandate at district level. In this backdrop, The Law & Justice Commission has desired to arrange exclusive training sessions for the District and Session Judges/Chairperson, the DLECs and the representatives of LJCP Secretariat vide letter # 14(198)/2005/LCJP-Islamabad/AJDF Dated 27th August, 2024 with the aim that this will help to address any quires regarding the operational aspect and benefits of DLECs, thereby fostering better awareness and promoting the effective and efficient use of the available free legal aid service.

With this background in view, the Khyber Pakhtunkhwa Judicial Academy has arranged 02 online Webinar Sessions for the District & Sessions Judges being ex-officio chairpersons of the DLECs and representatives of LJCP Secretariat.

OBJECTIVES

Objectives of the activity were to:

- Enhance understanding of the latest amendments in DLEC Rules, 2011.
- Help to address queries regarding the operational aspects and benefits of the DLECs.
- Foster better awareness and promoting the effective and efficient use of the available free legal aid services.

LEARNING OUTCOMES

At conclusion of activity it is expected that the participants will be able to:

- Have better understanding of the DLEC Rules, 2011.
- Appreciate effective implementation strategy.
- Create awareness about provision of the legal aid amongst judicial officers and all those concerned with administration of justice at district level.

- Solutions and strategies were explored to improve the efficiency of legal aid services.
