

Establishment


The Academy was established in 2012 under an Act of the KP Provincial Assembly. It is a body corporate having perpetual succession and a common seal with the power to acquire, hold and dispose of property and may by the said name sue or be sued.

Objective

The objective of the Academy is to impart judicial education to the judicial officers and personnel of all those concerned with the system of administration of justice with a view to develop their capacity, professional competence and ethical standards for efficient dispensation of justice, including matters connected or incidental to it.

Motto

The motto of the Academy is as under:

Mission

Role & Power of Board of Governors

The BoG exercise supervision and control over the affairs of the Academy through its Chairman. The Board primarily performs the functions of framing policies, programs for training, approval of budget, overseeing the financial matters, specifying service conditions for DG, faculty members and staff, create/abolish posts, acquire and dispose of the property of the Academy, affiliate Academy with other such institutions controlled by Federal, Provincial, Foreign Governments/ Organizations and make decisions with regard to collateral or incidental matters relating to aims and objectives of the Academy.

Efforts for Excellence

To promote continuing legal and judicial education, the Academy, vide KPJA Act No.XXI of 2015 on 12th May, 2015 (Annex-C) has been given mandate to:

- Provide higher education in the field of law and judicial studies; and
- award certificates, degrees, diplomas and other distinctions to the students and trainees and to prescribe standards of proficiency before awarding such degrees, diplomas, certificates and distinctions;


Trainings Imparted by the Academy

The training programs imparted by the Academy has different dimensions like field training, aptitude orientation, development of judicial attitude and






1.3 STRUCTURE



CHAPTER-2

ADMINISTRATION

The Administration Wing looks after the overall administration of the Academy led by the Senior Director Administration (SDA). This includes but not limited to general administration, logistics, accounts/finance, accommodation, messing, and all other routine affairs related to trainees, faculties, staff officers, and other support staffs.



2.2 7th Meeting of BoG of KPJA

The first session of the seventh meeting of BoG was held on 15th April, 2017 followed by another session on 9th June, 2017. Hon'ble Justice Yahya Afridi, Chairman of the BoG/hon'ble Chief Justice of the Peshawar High Court (PHC) chaired the meeting. Those who attended the meeting were; Mr. Justice Qaisar Rasheed, Senior Judge PHC, Mr. Sharif Ahmed Member Inspection Team PHC, Mr. Zaka-Ullah Khattak Additional Registrar (Admin) PHC, Mr. Wagar Ahmad Additional Advocate General-I Government of KP, Mr. Muhammad Arifeen Secretary Law, Parliamentary Affairs and Human Department Rights Government of KP, Mr. Muhammad Idrees Khan, Special Secretary Finance, Finance Department, Government of KP, Mr. Inayat-Ullah Principal Khyber Law College, Mr. Qaisar Alam, Chief Economic Analyst as representative for Additional Chief Secretary(P&D) and Mr. Masood Khan, DG Academy/Secretary. Mr. Masood as Secretary of the BoG welcomed the members of the BoG.

The agenda of the meeting was as under:

- 1. Budget Estimate for the year 2017-18
- 2. Schedule of new Establishment
- 3. KPJA Endowment Fund
- 4. Amendments in KPJA Act & Rules, 2012

In the first session of the meeting, agenda items No 1, 2 and 4 were marked to the Finance Committee while agenda item No 3 was assigned to Secretary, Law Khyber Pakhtunkhwa, to work out amendments in the parent Act i.e KPJA Act, 2012, for provision of Endowment Fund.

Agenda item No 1, 2 & 3 were approved and the law department was directed to begin procedure for amending the KPJA Act, 2012. Agenda item No. 4, to the extent of Rules for utilization of Endowment Fund and Promotion as admissible under section 8 of the KPJA Staff (Terms and Conditions of Service) Rules, 2012, was approved. However, the matters with regard to Staff's Pensionary Benefits

and General Provident Fund were deferred and it was decided that the matter shall be placed before the next BoG for consideration and approval.

2.3 Construction of Hostel Building:

The Academy remains frequently engaged in arranging seminars, conferences and workshops which are attended at times by judicial officers from outside the capital. It was thus deemed necessary that instead of accommodating the participants in rented buildings, the Academy should have its own hostel. The construction of hostel within the premises of the Academy was approved by Provincial Government Working Party (PDWP) in its meeting held on 12th April, 2016. The estimated cost is Rs29.810 million. Ground breaking ceremony of the hostel took place on 19th November, 2016 and actual work of construction started in April 2017. More than 75% of the work has been completed. The interest taken in the execution of the project is likely to enable the Academy to complete the project well before its scheduled date of completion.

2.4 Acquisition of Land in Regi Model Town:

The Academy also intends to purchase 150 Kanal of land in Regi Model Town for construction of the Academy. For the purpose of identification of site of land, DG, Peshawar Development Authority (PDA) was approached vide letter No 781-83/ KPJA dated 11/04/2017 in pursuance of the meeting held in PHC, on 1st March, 2017.

CHAPTER-3

ACADEMICS

3.1 Training courses: Capacity-Building Endeavors

In the year 2017, the Academy conducted the following trainings:

Pre-Service Training of Civil Judges-cum-Judicial Magistrates

The Academy arranged first ever pre service training of 103 Civil Judges cum Judicial Magistrates who were recruited after qualifying a competitive exam conducted by the Public Service Commission in the year 2016. The High Court had authorized the Academy to conduct such training courses vide Notification No 185 J dated 31st October 2015. The training was conducted in three batches per the following details:

The objectives of this pre service training were:

- To increase the trainees' knowledge of jurisprudence and universal principles of natural justice (principles ensuring fair trial)
- To enhance academic knowledge of the trainees in the basic legal concepts
- To impart skills to the trainees to effectively align legal concepts to their professional duties
- To make the trainees understand concept, meaning and scope of substantive and procedural laws and its efficient practical application
- To impart to the trainees efficient practical and effective management and communication skills
- To inculcate in the trainees judicial decision making and opinion (judgment) writing skills

- To sharpen their legal concepts professionally
- To impart to them basic skills necessary for efficient and effective performance of their judicial duties
- To enable the trainees learn and keep high moral standards by observing of moral virtues, professional ethics, team building and avoiding all sorts of sins and vices
- To develop in the participants the concepts of "Fear of Allah (SWT)" and
 "Ultimate Accountability of judges/Qazis in the Doomsday"

Two Weeks Pre-Induction Training for Probationer Additional District & Sessions Judges and Newly Promoted Additional District & Sessions Judges

The Academy also arranged a training course for 21 newly inducted Additional District & Sessions Judges and promoted Additional District & Sessions Judges. The training was organized from 16th to 27th October, 2017. The aim of the training was to develop their capacity, professional competence and ethical standards for efficient dispensation of justice.

One Day Training on Judicial Accounts & Financial Management for Senior Civil Judges (Newly Promoted)

One day training was conducted on 27th September, 2017 for 25 newly promoted Senior Civil Judges on Judicial Accounts and Financial Management. The participants were apprised on the topics of general financial rules, public procurement, financial management and budgetary matters.

Training for Young Lawyers

The Academy trained 100 lawyers from across the province. Four trainings were conducted in series and in each training 25 young lawyers participated. The objectives of the training programs were to inculcate and promote ethical values and standards in young lawyers and to improve their professional skills, enabling them for healthy relationship with the bench.

Training for KPJA Staff

On 24th & 25th April, 2017, a training was arranged for as many as 30 staff members of the Academy. The training focused on office procedure, management and ethics.

Two Days Specialized training on Financial Crimes

In order to understand the concept of financial crimes as well as its economic implication, to examine the legal mandate and practical implications of committees and financial monitoring unit, to combat money laundering and terrorist financing and to summarize the legal requirements for preventive measures to be adopted to combat financial and electronic crime, a two days training was conducted on 3rd and 4th May, 2017. A similar training was arranged on 19th and 20th July, 2017. Overall, 25 senior judicial officers of the District Judiciary participated in the training which included District & Sessions Judges and Additional District & Sessions Judges.

Training on Court and Case Management

With the purpose to sensitize the judicial officers about the delay in disposal of cases and to make them learn and apply the techniques of pre-trial conferencing, training programs were arranged with the assistance of United Nations Development Program (UNDP) as part of Strengthening Rule of Law Program (SRLP) in Malakand Project. The Academy arranged seven trainings in series during the months of July, September, October, November and December, 2017. In each of these trainings, 25 judicial officers participated.

Trainings of the Trainers on Strengthening Application of Bail Provisions for Juveniles (Children) in Conflict with law for Judicial Officers, Police, Probation, Prosecutors and Child Protection Officers

The Academy, in collaboration with United Nations Children Fund (UNICEF), conducted a base line study to assess the implementation of bail provisions under Juvenile Justice System Ordinance (JJSO), the Code of Criminal Procedure (CrPC) and to identify the areas for implementation. Thereafter, a

training was arranged for more than 30 judicial officers on 15th May, 2017 with the objective to impart knowledge and skill regarding the implementation of the JJSO in letter and spirit.

Another training for the implementation of the JJSO was conducted from 16th to 19th May, 2017 for the police, probation officers, prosecutors, child protection officers. The objective of the training was to impart knowledge and skills, to support the implementation of right based approach among the key stakeholders in direct contact with juveniles in conflict with law. In this training, 25 representatives from police, prosecution, probation and child protection department participated.

Two Days Specialized Training on Forensic Science for Judicial Officers

Two delegations of District & Sessions Judges visited Lahore in the months of September and October, for a specialized training on forensic science. The delegation was accompanied by Mr. Asif Khan, SDA, Mr. Sohail Sheraz Noorsani, SDR&P and Mr. Zia-ur-Rahman, Director Instructions (DI). The delegation was briefed about the activities and working of the Agency. The delegation also took round of the departments of the Punjab Forensic Science Agency Lahore, visited Punjab Judicial Academy (PJA) and Alternative Dispute Resolution (ADR) Center established in Lahore High Court.

One Day Training for KP Judiciary on International Humanitarian Law

The Academy with the support of International Committee of Red Cross (ICRC) and Research Society of International Law (RSIL) arranged three training sessions. The first training was conducted on 28th September, 2017, the second, on 31st October, 2017, and, third on 6th December, 2017. In each of the trainings, 25 judicial officers participated. The training sessions were conducted by national and international experts on the tenets of International Humanitarian Law and its domestic application. The training aimed at fostering better understanding regarding particular challenges in the interpretation and application of international humanitarian law and to review the current developments.

One Day Specialized Training on Declaration of Assets & Income Tax Returns

With the enactment of Income Tax Ordinance, 2001, every employee has to file Tax Returns with Declaration of Assets. Therefore, with the objective to comprehend the relevant laws/rules, to help the judicial officers understand proper filing of Income Tax Return and Declaration of Assets Forms and to equip them with financial management skills in individual as well as organizational capacity, the Academy arranged this training on 9th October, 2017 for 25 judicial officers from across the province.

One Day Consultation Session with Judicial Officers on Human Rights, International Protection and Legal Status of Refugees in Pakistan

A one day activity was arranged in the Academy with the support of Society for Human Rights and Prisoners' Aid (SHARP) on 10th October 2017. More than 25 judicial officers participated in this session. The objective of the activity was to develop understanding of human rights in the participants, to sensitize them about the legal status of the refugees and the international protection provided to them.

Two Days Training Course on Gender Mainstreaming & Women Empowerment

In order to refine the knowledge of the District Judiciary about Gender Justice, Gender Mainstreaming and to enable the judicial officers to differentiate between equitable and non-equitable differences in connection with rights and duties, the Academy, with the support of Gender Reform Action Plan (GRAP-Phase II), Social Welfare, Special Education and Women Empowerment Department KP, arranged training for 25 judicial officers on 11th and 12th October, 2017. The main objective of this training was to familiarize the judicial officers with international instruments on the subject and to ensure equal treatment to all before them irrespective of their language, color, culture, creed, caste, religion, sect and most important gender and to identify the potential steps, precedents, tools and techniques they have at their disposal.

One Day Session with Judicial Officers on Health Care, Nutrition and Stress Management

The Academy arranged one day training for 25 judicial officers on 19th October, 2017. The topic was "Health Care, Nutrition & Stress Management." The purpose of this training was to give knowledge to the judicial officers to enhance their capacity, both mental and physical, to groom them about health issues and to improve their quality of life.

One Week Sponsored Training Course on Substantive & Procedural Laws (Upgraded Manual) for Civil Judges

A one week training was arranged for 25 Civil Judges on Substantive & Procedural Laws from 23rd to 27th October, 2017. The objective behind this training was to enrich knowledge, sharpen the skills and to improve the service delivery of the Civil Judges for expeditious justice.

Two Days Training on Forensic Science for Judicial Officers

The Academy arranged training on Forensic Science for 25 judicial officers including District & Sessions Judges, Additional District & Sessions Judges, Senior Civil Judges and Civil Judges on 30th and 31st October, 2017. The purpose of this training was to enable the judicial officers to understand and disseminate forensic knowledge, appreciate forensic reports in its true perspective, practical use of Article 164 of the Qanoon-e-Shahadat Order, 1984 and efficiently interpret forensic reports.

Two Day Training Course on Cyber Crimes for Judicial Officers

This training was arranged on 2nd and 3rd November, 2017 by the Academy for 25 judicial officers in order to develop their knowledge of Cyber Crimes.

Two Days Training Course for Punjab Judicial Officers

In continuation of regular visits of Punjab Academy, a delegation of 19 District & Sessions Judges from Punjab visited the Academy in the month of August. The Academy arranged specialized trainings for the delegations of PJA. Two trainings were arranged, first on 3rd and 4th August and second on 24th and 25th

August, 2017. Lectures were delivered on "Research Methodology", "Law Giving Verses of Quran and Sunah" and "Stress, Self and Time Management." An interactive session was also held on the topic of "Challenges faced by the District Judiciary."

Two Days Training on Case and Court Management for District & Sessions Judges

Based on the revised manual, a training was arranged for 25 District & Sessions Judges on 14th and 15th November, 2017. The purpose was to sensitize them to delay in administration of justice and to make them learn and apply the techniques and concept of pre-trial conferencing and trial scheduling.

Trainings on ADR for Young Lawyers

Two trainings were arranged for young lawyers on ADR. First training was conducted from 20th to 24th November, 2017 and second from 4th to 8th December, 2017. The aim and objective of this training was to promote ethical values and standards and to improve their professional skills. A total 50 young lawyers from across the province participated in the trainings.

Two Weeks Training for Staff & Officers of District Judiciary Secretariat

The Secretariat of District Judiciary (SDJ) was established in PHC in the year 2017. For the capacity building of the staff and officers of the SDJ, the Academy arranged two weeks training from 11th to 20th December, 2017, for its 33 staff members and officers.

Two Day Training on Office & Court Management for Superintendents of District Judiciary

Under SRLM, the Academy also arranged two days training program for the Superintendents of District Judiciary on 18th and 19th December, 2017. As many as 25 superintendents of the District Judiciary attended the training.

3.2 Workshops

Workshop on FATA Reforms

The Government of Pakistan published a report on Federally Administered Tribal Areas (FATA) reforms, the Academy, in order to ensure the implementation of those reforms, arranged a workshop on 25th May, 2017, wherein 40 members from different sectors of society, including judicial officers, participated. A meaningful debate was conducted on the FATA reforms. The main objective of the workshop was to initiate a discourse on the future of the legal set up in FATA vis-à-vis the Riwaj Act and Jirga System.

One Day Workshop on District Judiciary Female Judges Study Tour to United Kingdom (UK)

In July 2017, the judges of the KP Judiciary visited the UK. The purpose was to expose the judges to court processes in the UK and help them understand how cases are managed with special focus on handling cases of violence against women and harassment. After their return from UK, the Academy, in collaboration with Justice System Support Program (JSSP), arranged a workshop on 17th August, 2017. The workshop was aimed to provide platform to female judicial officers to share their experiences and knowledge gained during their interactions in the UK. The workshop was attended by JSSP officials, the SDA and DR&P of the Academy, the judicial officers who visited UK and other judicial officers of the District Judiciary.

3.3 Seminars

Seminar on Proposed Amendments in CrPC and PPC

The Ministry of Law, Parliamentary Affairs, Government of Pakistan proposed some amendments in the CrPC and the Pakistan Penal Code (PPC). The Academy, as per statutory mandate and under the special directives of hon'ble Chief Justice of the PHC, arranged two days seminar on the proposed amendments on 21st and 22nd March, 2017. The seminar was attended by a cross

section of participants from justice sector institutions. Hon'ble the Chief Justice Justice Yahya Afridi also graced the occasion by his presence.

National One Day Seminar on Case Management and Summary Judgment Rules

The Islamabad High Court invited objections and suggestions on the proposed Case Management and Summary Judgment Rules (Amendment in Civil Procedure Code) and Notification SRO 1038(I)/2016 was issued by the Government of Pakistan. The Academy arranged a one day seminar on 18th April, 2017, on the subject. The objective was to initiate an academic discourse on the subject and to form recommendations for consideration and promulgation of the rule-based regime for case flow management. Those who participated in the seminar were members of the Rules Committee of PHC, Justice Rohulamin Khan, Justice Qalandar Ali Khan and Justice Muhammad Ibrahim, member of the Islamabad High Court Rules Committee, officers of Punjab, Sindh, Balochistan and Federal Judicial Academies, District & Sessions Judges, senior lawyers, Additional Secretary Law KP and other stakeholders of law and justice sector.

Seminar on Fast Track Dispute Resolution for Investment Contracts and Transactions

On 23rd May, 2017, one day seminar on Fast Track Dispute Resolution for Investment Contracts and Transactions was conducted by the Academy. In the seminar, 30 judges, lawyers, members of Chamber of Commerce, Bar Associations, representatives of the FATA political administration and private enterprise, participated. The seminar was aimed to provide basic information on investment contracts and transactions with special focus on informal dispute resolution and to identify the issues and gaps in the present system and the recommended mandate for the establishment of procedures and rules for the conduct of fast track dispute resolution between the contracting parties.

One Day Seminar on Etiquette & Mannerism for Capacity Building of Special Courts/ Tribunals & Law Officers of Federal Government

Judicial ethics and etiquette is an important discipline of judicial education and the conduct of a judicial officer both inside and outside the court plays an important role in creating trust in the judicial system. The Academy, in this regard arranged one day seminar on 24th May, 2017 in which 25 judicial officers and representatives of other stakeholders participated. The purpose of the seminar was to assist the judicial officers in the identification of the ethical challenges and the ways and means to resolve them in line with relevant laws.

3.4 Conferences

Two Day National Conference on ADR

Under SRLM, a project funded by European Union, the Academy organized two days National Conference in Islamabad on 16th and 17th November, 2017. The aim was to discuss the issues and challenges of existing formal and informal ADR mechanisms and provide a forum to the stakeholders to deliberate on effective ADR mechanism for the province. To achieve the given objectives of the conference, the experts and practitioners from judiciary and legal fraternity, academia and civil society from all over the country, shared their views. Through group discussion and deliberations, the members recommended an appropriate and effective ADR mechanism for the province of KP and to devise communication strategies for sensitization and engagement of all stakeholders on ADR mechanism.





CHAPTER-6

INFORMATION AND COMMUNICATION TECHNOLOGY

6.1 IT Facilities and their Utilization

The Academy has certain Information Technology (IT) infrastructure. All the offices, class rooms, auditorium and computer labs are related to local area network (LAN). The Wi-Fi facility is also available in the Academy. The Academy has its own website which is regularly maintained, updated and improved. The catalogue of the library is automated and a software has been indigenously programmed at the Academy. The catalogue has been uploaded to the website and is accessible to the public. Similarly, an asset tracking system has also been designed and programmed by the Academy's programmer. It keeps track of all movable assets of the Academy and it is updated through bar code readers. The IT wing has also developed a prototype of training database called the Activity Management System (AMS). It regularly updates the training profiles of both trainers and trainees. It has a separate module meant for evaluation. This system works online through randomly sorted multiple choice questions. In this way both the trainees and the trainers can be objectively evaluated. At an elementary level, there is payroll software in operation which has also been designed in the Academy.

6.2 Radio Meezan FM 96.6

The Academy runs an FM Radio by the name Radio Meezan. The purpose of the Radio is to inform and educate its public about the legal and judicial system. The Radio covers District Peshawar area and runs its programs from 03:00 pm to 07:00 pm. It receive feedback via




